Waiver and Release Form

In exchange for being permitted to participate in any activity, I/we will not institute any action at law or in equity on account of any injury or other loss or damage sustained, or that may be sustained, by me/us as a consequence of my/our participation in any activity sponsored in full or in part by AUE. My/our participation in any activity offered by AUE is strictly voluntary.

I/we understand that AUE and/or no other member of the club shall, in any way, be responsible for the safety of any member, or be responsible for the services or accommodations being offered by other enterprises or persons on all trips and/or activities, scheduled or unscheduled by this club.

I/we agree to abide by the Bylaws, rules and regulations of AUE. I will abide by safe practices and conduct my behavior in a responsible manner. This Waiver and Release form shall be binding on myself/ourselves and on behalf of my/our heirs, agents, assigns and legal representatives.
